Judges –

- Tests not being turned in -
 - Joann & Candi have been discussing.
 - Judges not sending their tests in.
 - What do we do?
 - Set a date.
 - If test not done pull them off the list.
 - If you hired them and they don't do the test "un-hire" them and if you can, find a replacement.
 - If we do the testing earlier we would have to have our patterns and rule changes completed.
 - Do test at training but can't because rule books aren't out.

- We need to have a clause in the contract that said if they have not completed and send their test by a deadline and pass the test the contract will be voided.
- Candi will redo the contract that we have posted for Districts to utilize.
- Timers need to be official and should be paid the same as judges.

State Meet –

 - Candi will look into this to see if it will work with our schedule.
- State Record for Team Penning
 - \circ $\;$ Nick wanted to know why we don't have a state record time in team penning.
 - Send Scott your district's record time.
 - Chris motioned that it be on the fastest go with 3 cows. Seconded by Corinne.
 - o Vote: 12 Yes, 0 No, 1 Abstain. Motion passed.
- EMT
 - Redmond Fire is no longer providing this service.
 - We have contracted with a new company.
 - They will be setting up a tent and have their equipment out there.
- Baskets
 - We will be having just a few big baskets not one from every district.
- Duties
 - Will be getting them up on line soon.
 - Candi will be doing a sheet per District.
 - Then each district could pull their sheet and get their volunteers to sign up.
 - This will be done by volunteer slot.
 - Once a person signs up for the job it automatically adds the job to their calendar. Their cell # is also entered and it will send them a reminder message.
 - Sherri reminded everyone that if they sign up for scribing they need to have prior experience.
 - Athletes can rake but cannot do the gate or scribe.

- This was not an issue of footing, over mounted, or caused by anyone else.
- It was just an accident.
