### **Props in Drill**

- Are props allowed? There's no specific rule against it. A team has requested to use a smoke machine. The consensus was a strong "No" to this.
- Are costumes on riders allowed? Rule book p. 61 ribbons, glitter, sparkles on equine are optional. In Working Pairs, rules specifically allow costumes are allowed on equine only. The consensus was that since rules do not specifically allow for costumes, they should not be allowed.

#### **Rule Book Corrections**

- Team Penning, bottom of page 51 "split reins are allowed for team penning" was accidentally omitted.
- Keyhole, page 85, section 3 change to say "stepping on our outside of line is considered OFF COURSE." Get rid of section 4 about all four feet, etc.

#### **Complaints/Conflicts**

Candi said District Chairs are getting a lot more complaints. She thinks this is because we
are holding more firmly to our rules and people are somewhat used to getting around
rules to have things their own way. She said she's sorry for the difficulty and stress it

- creates for District Chairs, but that she believes it is the right thing to do, and that it gives more credibility to our organization.
- Candi said she recently got a call from a state representative who contacted her to find
  out why a particular athlete's request was turned down by the state board. They talked
  about it and Candi felt it turned out very positively, and that the state representative
  was impressed with the organization.

#### **Medical Insurance**

- Our medical insurance is now in place. A Philomath rider broke her arm already this season, and will be the first one to use the new insurance.
- Candi created an accident report form which is now online. Claimants should turn it in to their District Chair who will turn it in to Candi, who will file the claim with the insurance company.
- People who aren't affiliated with a team, like Candi, JoAnn Oswald, etc. can be covered, but we need to generate some paperwork for them to complete to provide them with coverage. This would only provide coverage when they are working as a volunteer for the organization, not when they are working as a contractor (ie while judging).

## **New Points Program**

Don says this is coming along fine. The new version will be ready in a few days. Most
districts already have the program. They have discovered a couple of bugs, but no major
problems. He expects to have it fixed this weekend.
