- Chris motioned that OHSET become a sponsor for AYHC 2015 for up to \$800 and have bags printed with our logo on them. Sue seconded the motion.
- Discussion
 - o This was not in the proposed budget, but the budget can be amended to include.
- Vote Unanimous. Motion passed.
- Since costs will be down this year (airline costs), could we sponsor more than one or two youth?
 - Would spend the same on the youth, but would like to have more participate in the conference.
 - We only had two apply this year.
 - o Have booked a house at Eagle Crest for the youth to stay in.
 - Discussion on how to get more youth to participate
 - If youth paid for their registration, could they have housing and a shirt covered?
 - Open up to other youth besides those that have applied?
 - Allow those that have already participated at an AYHC to come? Would pay for housing and already have their shirt.
 - How many youth (and chaperone) can the house hold? What is the cost per head?
 - Can youth pay their own way and still have the opportunity to stay at the house?
 - Will be a challenge for those youth participating at the Central District meet to be involved with the conference.
 - Leave the application open for more youth to apply? There was a deadline for those that did apply.
 - There is a budget for \$1500 to send those to the conference.

Rule Changes Vote -

- Please see attached Rules Committee Minutes for the listing of the proposed rule changes. Only those proposed rule changes listed below were recommended to the state board for approval. Please refer back to the Rules Committee minutes for the corresponding proposed rule change.
 - #15 Raised Dressage Courts for the State Meets.
 - The Rules Committee recommends: Yes use raised Dressage court for the state meets. (8 Yes, 0 No)
 - State Board Vote –
 Yes 20. Raised Dressage courts will now be required at the state meets.
 Rule will be added.
 - o #3 Allows an alternate for 2 person teams.
 - The Rules Committee recommends: Yes, allow alternates for all 2 person teams at the district meets and the state meets. (7 Yes, 1 No)
 - State Board Vote –
 Yes 19. Alternates will now be allowed for all 2 person teams at the district meets and the state meets. Rule will be added.
 - #4 Athletes can be declared at the state meet before the first horse enters the gate of that event.
 - The Rules Committee recommends: Yes, an athlete can be declared at the state meet before the first horse enters the gate of that event. (7 Yes, 1 No)
 - State Board Vote –
 Yes 17, No 3. An athlete can be declared at the state meets before the first horse enters the gate of that event. Rule will be added.
 - **#5** Allows for the option of a solid, long sleeved, button up shirt as a uniform shirt.
 - The Rules Committee recommends: No, do not allow the option of a solid, long sleeved, button up shirt for a uniform shirt. (1 Yes, 7 No)
 - State Board Vote –
 Yes 3, No 17. NO solid, long sleeved, button up shirts will be allowed as an option. NO rule change.
 - #6 OHSET season would begin on November 1st.
 - The Rules Committee recommends: Yes, change the start of the OHSET season to November 1st. (5 Yes, 3 No)
 - State Board Vote –



Yes 13, No 7. The start of the OHSET season will begin on November 1st. Rule will be added.

- #10 Backup timer will start the time when the nose of the cow crosses the cow barrier line.
 - The Rules Committee recommends: No, the backup timer is to watch the judge and when the flag drops – the time will start. (1 Yes, 6 No, 1 Abstain)
 - State Board Vote –
 Yes 3, No 17. The backup timer will continue to watch the drop of the flag from the judge to start the time. NO rule change.
- o #11 Remove Rule 15.11.1.1 from Break Away Roping.
 - The Rules Committee recommends: Yes, remove this rule 15.11.1.1 from the Break Away Roping section. (7 Yes, 1 No)
 - State Board Vote –
 Yes 19, No 1. Will remove Rule 15.11.1.1 from the Break Away Roping section. Will be removed.
- #12 Change that only registered volunteers can be in the arena for Break Away Roping and Steer Daubing.
 - The Rules Committee recommends: No, leave rule as it is. Any adult can be in the arena for Break Away Roping and Steer Daubing. (7 Yes, 1 No)
 - State Board Vote –
 Yes 4, No 16. Any adult can be in the arena for Break Away Roping and
 Steer Daubing. NO rule change.
- #19 Change from Key Hole to Key Race.
 - The Rules Committee recommends: No, leave event as Key Hole. (3 Yes, 4 No, 1 Abstain)
 - State Board Vote –
 Yes 4, No 13, Abstain 3. Event will stay as Key Hole. NO rule change.

Redistricting Proposals –

- The proposals were to be taken back to the districts for discussion and brought back to this meeting to be voted on.
- Northeast District Proposal
 - There is still the December 1st deadline.
 - The redistricting committee's recommendation was
 - That we allow Wilson, Lincoln, Clackamas, Centennial, and Corbett to compete in the North West district, Sandy and Estacada to compete in the Willamette OR the Central district, and Sam Barlow to compete in the Tri-River district for the 2014-2015 season <u>only</u> if the Oregon Equestrian Center is not available to host the meets by the December 1st deadline.



- Jenny motioned that the state board accept the redistricting proposal for the Northeast District as recommended by the redistricting committee. Chris seconded the motion.
- Discussion
 - What about the two school that could choose where they go?
 - Have they decided if we need to redistrict for this year?
 - Sandy would go to Central. Not sure of Estacada.
- Vote Yes 20. Unanimous. Motion passed.
- Yamhill-Carlton Redistricting
 - The redistricting committee recommendation was
 - Do not allow the Yamhill-Carlton team to move from the North Valley district to the North West district.
 - Chris motioned that the state board not accept the redistricting proposal for the Yamhill-Carlton moved as recommended by the redistricting committee. Wendy seconded the motion.
 - No discussion.
 - Vote Yes 18, No 0, Abstain 2. Motion passed. Yamhill-Carlton will stay in the North Valley District.

 - One from Southern and South Valley. This is a cross district co-op.
 - Chris motioned to accept this non-standard co-op. Jenny seconded the motion.
 - No discussion.
 - Vote Yes 19 No 0. Motion passed. (One voter stepped out of the room during the vote.)
- Eligibility Issues
 - See attached listing of eligibility issue.
 - Concerning an athlete in the South Valley district.



- Sue motioned to allow this athlete to compete on the Pleasant Hill High School team because of her medical issues. Jenny seconded the motion.
- Discussion

 - The athlete is a junior.
 - She has never competed in OHSET before.
 - Eligibility exceptions are good for one year only.
 - This athlete needs the support system she has at the requested school.

Medals -

- Must leave Bend Awards.
 - They have been non-communicative.
 - They have been unreliable.
 - Their location is a mess.
- Candi has contacted 3 other medal providers and the least expensive if we order 3 years at a time (equal or better quality) are
 - \$4.60 each for state medals.
 - \$3.50 each for district medals.
 - Both include engraving.
 - This is a .55 cent increase over last year's district medals and a \$1.35 increase over last year's state medals.
 - There is no additional set up charges.
 - This translates into an additional \$75 cost per district and an additional \$200 cost for the state.
 - Candi is comfortable with the new provider. Has done other work with them.
 - Should she keep looking?
 - o Do we want to do away with medals?
- Consensus is to do what Candi fees is best for the organization.
- Do we want to do something different than medals? Can we do something different?
- Will the medals be of a better quality?



- What do the youth think?
 - The youth at the meeting like the medals.
 - They are unique to OHSET.
 - Would like a better quality.
 - O What about something like the 4-H medallions?
- Donna motioned to accept what Candi has proposed with the new provider and the additional costs. Wendy seconded the motion.
- Discussion
 - o Can we get a better quality for a bit more money?
- Donna withdrew the motion.
- Donna motioned to accept what Candi has proposed with the new provider and the additional cost and to increase the quality of the medal up to \$1 per medal. Wendy seconded the motion.

- Vote Unanimous. Motion passed.
