 - Dissolve NE district this is the proposal that was chosen.

 - Lots of time and thought went into this it wasn't easy.
 - Change can be hard for anything.
 - For the health and competitiveness of the organization we need to make the change and it will be difficult.
 - Doesn't change the facts of the organization and the way the organization is going.
 - Please trust and consider the process that the committee had to do to come up with the proposal.
