New Business

Alternate Athlete Issue -

- Points (don't have to ride to get points if an alternate) vs what the rule book states (athlete does have to ride to get the points).
- Will be looking into this.
- Needs to be brought up with new rule book printing this next year.
 Points (don't have to ride to get points) vs. rule book (states athlete has to ride to get points)

Weather Re-schedules and Challenges –

- Having to stop the meet early.
- Schools saying no to allowing athletes to travel.
- What are our responsibilities?
- What do we do when canceling a meet?
- Suggestion to take averages from two meets instead of three meets.
- SV will be having a "super meet" and seems to be working out so far.



- Couple of districts had to cancel some classes but seem to be fine and will make them up at the next meet.
- NW District
 - Had bad weather first meet and some teams did not come because schools said no travel.
 - Those schools want to be able to make up those classes missed.
 - Allowing this could be detrimental to other kids.
 - District voted to not allow this.
 - Need an SOG for weather cancellations.
 - Needs to be geared to what districts should do.
 - If event(s) cancelled
 - Need to be registered at the first meet to ride again at the next "make up" meet.
 - Cancelling a meet needs to be for safety reasons.
 - Need to have written record if a school is not allowing athletes to travel and/or if school cancels classes.
 - Average of 2 meets if can't have 3?
 - Candi will work on a SOG.

Cargo Trailer -
